For safety reasons, the R. G. Drage Career Center does not recommend students riding, driving, or transporting other students to and from school in private vehicles. Bus transportation is provided daily to and from the Career Center and we strongly encourage its use.

If it is necessary for students to use private means of transportation to and from the R. G. Drage Career Center, it is understood that the students and/or their parent/guardian assume the responsibility of any consequences from this means of transportation.

The driver of a private vehicle driven to school assumes the responsibility of arriving on time and adhering to the rules and regulations established for this privilege. **Habitual violators of these rules and regulations will have their driving privileges suspended.**

RULES AND REGULATIONS

1. No student shall drive to and from school or park his/her car on school grounds without a permit.
2. No student shall violate the *Rules and Regulations* governing operation of a vehicle on school property.
3. Upon arrival at school, students are to go **DIRECTLY** into the building and **ARE NOT** to remain in their cars.
4. Students **MUST** park in designated areas.
5. Students are prohibited from driving during their lunch periods.
6. The car used by the student must be registered to him/her or a family member.
7. Any cars parked on the grounds without a driving permit will be subject to be **towed at the owner's expense.**

TARDIES TO SCHOOL

Students who are tardy to school **MUST** report to the *Attendance Office* for an **Admit Slip before** reporting to class. The violations below are based on a "per semester" basis.

- Upon the 4th violation, students may serve one (1) "after school" detention
- Upon the 5th violation, students may serve one (1) "all day" detention
- Upon the 6th violation, students may serve two (2) "all day" detentions
- Upon the 7th violation, students may serve one (1) "in school" suspension
- Upon the 8th violation, students may serve two (2) days "in-school" suspensions and loss of driving privileges.
